Installation Instructions

The 912HP is designed for use in non-health hazard continuous pressure applications and provides protection against backpressure and backsiphonage backflow.

- Can be installed horizontally or vertically, flow-up or flow-down.
- Prior to installation, flush the pipe lines to remove foreign material.
- Clean the strainer every six months or as conditions require.
- Some discharge from the vent is expected especially during start-up until all seating surfaces seal. Continuous discharge is an indication that the check valve components may require cleaning.
- Quick closing valves, water hammer or supply pressure fluctuations can cause intermittent discharge. The installation of a water hammer arrestor (Watts Series 05) or water pressure reducing valve (Watts N35B) may be required to correct the problem.
- It is important not to install the valve where discharge can cause damage. Pipe the discharge line in accordance with local code requirements. A physical air gap must be maintained between the discharge pipe and the drain. Create the air gap by cutting the pipe on a 45 bevel, at a distance of 12" (300mm) above the floor drain or through an air gap piped to a floor drain. Under no circumstances should the vent opening or drain line be plugged.
- Inquire with governing authorities for local installation requirements.


